The HCC acts as a resource to:

- Develop, review and approve a health care plan for the child care program that meets both regulatory requirements and best practice recommendations.
- When a Health Care Plan is required, a site visit from the HCC is required annually as well as when other plan changes need approval.
- Answer questions about common child care health related issues.
- Provide technical assistance during your creation of policies and procedures to help keep children and adults in your program safe and healthy.
- Provide training and education about health related issues (additional fees may apply)

Medication Administration Training “MAT” Certification

- The New York State Office of Children and Family Services (OCFS) has specific regulations about giving medication to children in child day care settings.
- The regulations require all child day care programs that choose to administer medication, other than over-the-counter topical ointments, sunscreen and topically applied insect repellent, to meet certain conditions including having staff who are approved to give medication in a childcare setting.
- The MAT course is a skill-based training to help you administer medication safely in your program. The course is eight (8) hours of training and includes a video training component as well as hands-on-demonstrations.

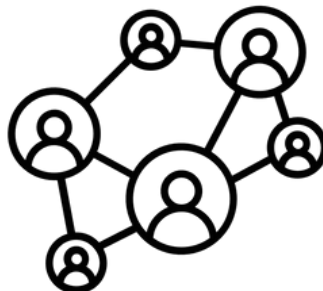

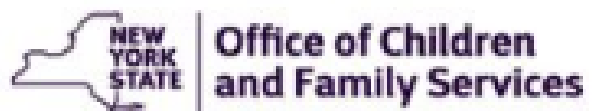

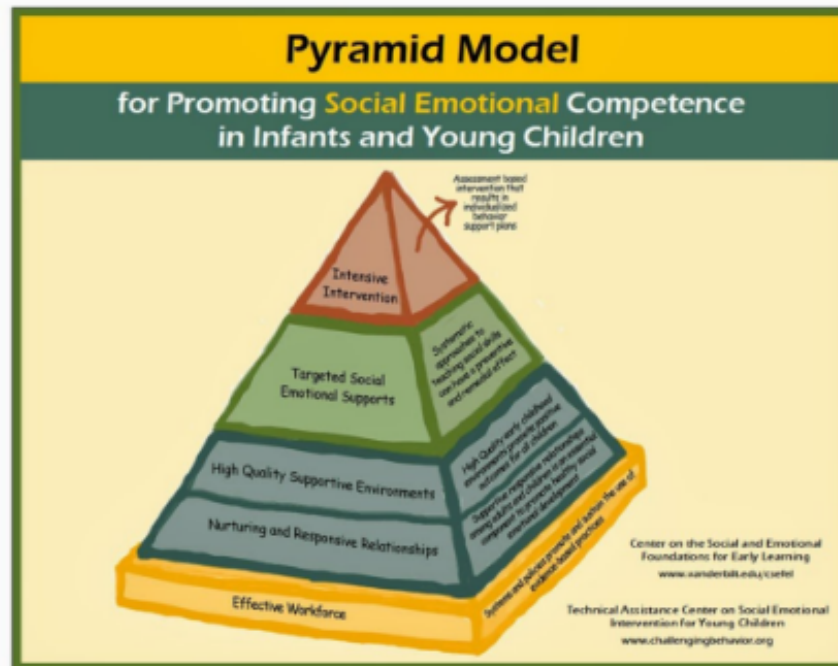

The Pyramid Model is a comprehensive, multi-tiered framework of evidence-based practices that promotes the social, emotional, and behavioral development of young children. The emphasis of this framework is to support all children at the universal level, thereby decreasing the need for more intensive intervention. In fact, when implementing the Pyramid Model framework effectively, only a very small percent of children will need intensive intervention. The guiding principles of this model include promoting skill building with enough intensity to affect change, implementing strategies in the context of naturally occurring routines and environments, and modifying strategies so they are responsive to the cultural and linguistic diversity of families and children.

The Pyramid Model can be used in any setting that serves young children. Families should be partners in all tiers. The Pyramid Model is not a curriculum, but rather a framework to promote social-emotional development.

*****All new directors hired since October 1, 2017 are required to take this training.*****

Different from the basic health and safety course, this one is designed so that directors can modify and/or create effective health and safety policies that will lead to Best Practice. All participants will receive 15 hours of training. EIP available for those who qualify. 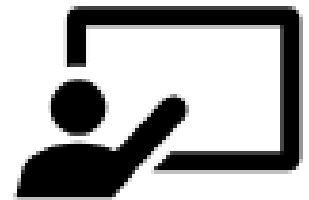

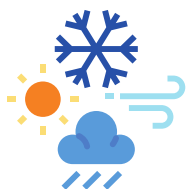
CFR Registration & Payment Policies



- Pre-Registration is **REQUIRED** for all training sessions.
- Submit the **SIGNED** training registration form and payment to Amanda Hines **1 WEEK** prior to the class date.
- Phone registrations will be accepted, however, a signed registration form and payment must be received by CFR **1 WEEK** prior to the scheduled training date. Your seat will not be reserved until payment and form are received.



- If applying for an EIP scholarship to cover costs of training, please include your **EIP Confirmation Number** that starts with **"CONF #EIP"** on your registration form.
- A person may not register for another training until **all past due fees are paid or we have received notification from SUNY of EIP funds**. If you have extenuating circumstance, please contact Candi Hart at 315-536-1134 ext. 2302



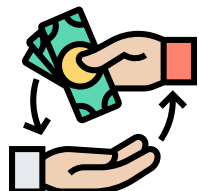
- Classes may be cancelled due to... inclement weather, trainer emergency, etc. **ONLY those participants who have registered and paid for a training session will be notified of cancellations or changes.**



- In extreme circumstances, certificates will be adjusted for participants that arrive late for a class. If a participant knows ahead of time, they can email their facilitator. **If the participant is over 15 minutes late for class, the trainer may refuse entry into the class or may adjust the certificate to reflect the correct time for participants actual training.** This is a case-by-case basis



- **Childcare is not provided at trainings.** Please make appropriate care arrangements. Children at trainings are most often disruptive to other learners and facilitators. Training topics can also be inappropriate for children.



- A refund or credit voucher will be issued when participants cancel their training registration **at least three (3) business days prior to the class**. Credit vouchers have an expiration date, one year from the date issued to the provider. CFR does not issue refunds or credit vouchers when participants do not show up at training unless there are extenuating circumstances. These will be reviewed on a case-by-case basis.

**Other than out of pocket or employer funded,
one of your options is the Educational Incentive Program (EIP).**

This program is EASY to apply for and designed to provide scholarship funding for childcare professionals. EIP is funded by the NY State Office of Children & Family Services and administered by the State University of New York (SUNY). Scholarships are awarded based on income.

Applicants may apply for scholarships for:

- Credit or non-credit bearing courses, workshops, conferences or training programs.
- Credential or certificate fees.
- Training and assessment fees for CDA using a separate CDA EIP Application.
- *The maximum award amount for college courses is \$2,500 per year.*
- *The maximum award amount for CDA and credential training is \$2,500.*
- *The maximum award amount for non-credit bearing training is \$700 per year.*

Apply IMMEDIATELY - Funds are Limited!

- EIP will fund a maximum of \$30 per hour with Verified Trainer or a Content Specialist, or distance learning training (maximum \$600) OR up to \$35 per training hour if training *is provided by a New York State Early Learning Trainer Credential (NYSELTC) endorsed trainer (maximum \$700)* for coaching taken with an approved coach maximum rate is \$55 per hour maximum annual amount of \$1,100.
- Submission deadline dates are set by SUNY. Providers are responsible for applying based on the course deadlines set on the SUNY EIP website. Get your EIP applications in early before funds are depleted!!!

EIP Scholarship Process/ 6 Simple Steps

1. Create an Early Childhood Education and Training Program (ECETP) account; complete an EIP application online at www.ecetp.pdp.albany.edu. All supporting documents will be uploaded during the application process. Have all your documents ready before you start. OR Complete a paper application and mail it with all your required documents to EIP. Online applications are preferred.
2. EIP processes the application. (Allow 4-6 weeks.)
3. You will receive an email notifying you of an award or if additional documentation is required. You will receive one email for each approved or declined activity.
4. Use the link in the email to review the terms and conditions and electronically sign your award. The award will be valid for 60 days from the issue date. EIP will automatically cancel the award if it is not accepted within 60 days.
5. Once the award is accepted, Child & Family Resources, Inc. will receive an email notifying them of awards to review. Using the link provided, Child & Family Resources, Inc. will review the terms and conditions and sign the award electronically within 90 days of receipt. EIP will automatically cancel the award if it is not accepted within 90 days. Please contact EIP to request your award be reissued if it has expired.
6. EIP processes a check payable to Child & Family Resources on your behalf.

The Core Body of Knowledge (CBK)

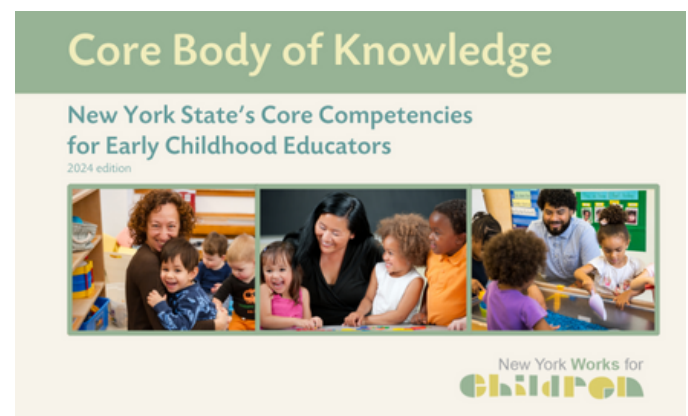
New York State's Core Competencies for Early Childhood Educators was written to outline recommended practices for professionals who work with young children.

These practices offer a road map for building meaningful relationships with children, families and colleagues, for creating nurturing, stimulating environments, and for developing oneself as a professional in this incredibly important field.

7 Core Competencies:

- **Child Development and Learning in Context (CBK 1)**
- **Family and Community Engagement (CBK 2)**
- **Observation and Assessment (CBK 3)**
- **Learning Environment (CBK 4)**
- **Curriculum and Teaching (CBK 5)**

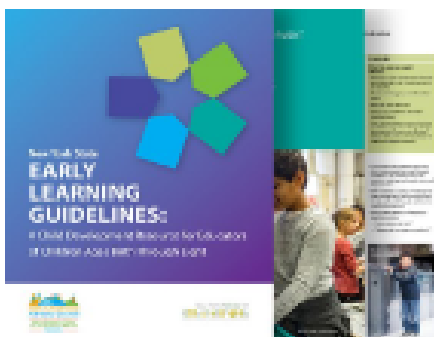


Early Learning Guidelines (ELG)

In order to do the work we each do for young children, we need to truly understand children. We need to know how they develop, and we need to embrace all the strategies to support, encourage, and affirm their healthy development. We need to be adept at explaining child development to families and help them understand our role, as partners, in the growth and development of their children. The best professionals are always learning and developing their skills. The Early Learning Guidelines are designed to be used as a resource, to support the professional development of those responsible for the care and education of our youngest citizens. The Guidelines were designed to complement the NYS Core Body of Knowledge.

According to NYS Child Care Regulations: Operators, Program Directors, Employees and Assistants of:



**Registered School Age Child Care Programs
Registered Family Child Care Homes
Licensed Group Family Child Care Homes
Licensed Child Care Centers**



Must meet the following requirements:

- Complete 30 hours of training every 2 years of their registration/license period—all modalities: FDC, GFDC, Center and SACC staff including assistants, volunteers, and substitutes
- Family and Group Family Providers must ALSO receive approved Health and Safety Training: Competencies for Becoming a Family or Group Family Day Care Provider & CPR and First Aid BEFORE being licensed or registered for the first time. This training may count towards the provider's overall 30-hour training requirement.
- New providers must complete a minimum of 15 of their training hours within the first six months of their first registration/license or employment period. For FDC/GFDC homes, Health & Safety fulfills this requirement if taken while provider's application is in-process.
- All Center and SACC staff must take the 5-hour Foundations in Health and Safety e-learning course within the first 90 days of starting their position.
- All training documentation must be kept on file in the provider's home or center.
- Cardiopulmonary Resuscitation (CPR) and First Aid Training Requirement: At least one employee who holds a valid certificate in CPR and First Aid must be on the premise of the childcare program during program operating hours.

The 30 hours every 2 years must include the following ten training topics:

- Principles of Early Childhood Development (CD)
- Nutrition and health Needs of Infants and Children (NH)
- Child Day Care Program Development (PD)
- Safety and Security Procedures (SS)
 - *(including CPR & First Aid)
- Business Record Maintenance and Management (BR)
- Child Abuse and Maltreatment Identification/Prevention (CA)
- Statutes & Regulations Pertaining to Child Day Care (SDC)
- Statutes & Regulations Pertaining to Child Abuse (SCA)
- Education and Information on the Identification, Diagnosis and Prevention of Shaken Baby Syndrome (SBS)
 - School-Age Child Care Programs are not required to obtain SBS
- Adverse Childhood Experiences, focused on understanding trauma and on nurturing resiliency (ACE)

**There is no minimum number of hours required in each topic area.
However you do need to attend a minimum of 5 training hours each year.**
