## Families in Transition



Families in Transition is a Parent Education program using the Assisting Children through Transition (ACT) curriculum. The program is designed to help parents separating from their spouse or partner or going through a divorce understand the impact their actions have on their children.

- Parents may attend independently or via court order or referral.
- Designed to reduce conflicts so they may effectively parent apart without negative effects on children.
- Parent handbooks and informative handouts are included in the program.
- Experienced and trained facilitators present the material in evening, weekday or Saturday sessions equaling 6 hours. Sessions will include a legal presentation examining the legal aspects of divorce and custody.
- Court ordered or referred parents must attend both sessions.
- Parents will not be enrolled together in the same class.
- Classes will be held in various locations. All locations are secure as safety precautions are considered.

## A Child's Rights:

*Children have rights to peace.....*

Children have the right not to be caught in the middle of their parents' conflict nor to be asked to choose between parents.

*Children have rights to role models....*



Children should not have to hear the "bad things" about the other parent nor to be questioned after visitation.

*Children have rights to be heard.....*

Children have the right to choose whether to express their feelings or not.



*Children have rights to love....*

Children have the right not to have to feel guilt for loving both parents.
